



Standing Firm in Building Resilient Communities through Social Security



Standing firm. These two words accurately describe the CCT Mutual Benefit Association, Inc. (CMBA), having surmounted the aftermath of a global pandemic that could have hindered its ministry among thousands of vulnerable families. Rising above a myriad of challenges, CMBA is back on its feet againimbuing hope and security to low-income Filipino families with greater stability and strength.



MINISTRY HIGHLIGHTS

From Mourning to Dancing. Imagine a world where remembering and honoring departed loved ones becomes a celebration of a life well-lived. A resounding testament to God's faithfulness in the family's life, and an overflow of thanksgiving and gratitude. A memorial filled with joy, shalom, and a bright hope for the things to come.

For more than three decades of journeying with the poor, CCT has proven the truthfulness of God's Word. As He promised, the poor, indeed, can find prosperity amid grief. They can find relief when they are hurting and sick. And above all, shalom is available to them even in their darkest moments of loss.

From small, simple acts of compassion and bayanihan in the community, to formally being able to provide microinsurance benefits—CCT has come a long way in ensuring the poor's access to basic social security, all because of the Holy Spirit's leading. The noble mission to uphold equal access to risk protection and to stand firm with marginalized Filipinos against economic inequalities has been CMBA's calling since its inception in 2017.

Radiating joy and rootedness of faith, CMBA has worked hand-in-hand with other CCT ministries to minister to countless families of community partners, staff, and other members—providing emotional support and facilitating healing through Spirit-filled memorial services and prayer gatherings. In such times, CMBA has been a true extended family, offering essential support and assistance to its members. Its impact extends to various sectors such as microentrepreneurs, tribal groups, Christian development workers, pastors, and communities at large.

Breaking New Grounds. Far from CCT's modest beginnings of giving flowers and PhP500 burial assistance during its early years, CMBA handed families benefits in 2023 like never before. Prioritizing its members' need for expanded benefits, CMBA put together a bundled microinsurance product called BLIP-Sigurado (Basic Life Insurance Plan-Sigurado, which means assured) that grants members up to PhP130,000 death benefits by contributing the same amount of PhP30 per week.

The 31% growth in membership indicates that more families are open to setting aside savings to prepare for future events that may affect their financial standing. And as the year closed, CMBA has ministered to more than 2,000 disadvantaged households, which translates to thousands of families rescued from the risk of falling into debt which is common among families with limited resources.

Cultivating Leadership. As CMBA continues to build lives, the Lord is also faithful in strengthening its governance framework. The entry of new board members with diverse experiences has brought a wealth of invaluable perspectives and insights to the ministry. Each member's unique background and expertise has contributed to a deeper understanding of the challenges and opportunities the organization faced, resulting in better risk management and financial stability.

Moreover, CMBA staff and the board members had the opportunity to fellowship with one another. They fostered a stronger connection as the boards actively engaged in discussions and raised relevant questions concerning the ministry. Joy and trust were palpable, and the strengthened relationship has continued to bear fruit—enabling the staff to confidently seek assistance from the boards who are eager and willing to help at any time.

The empowerment emanated from top-level management to the frontline staff. Through capacity-building and a decentralized approach to operations, CMBA officers were trained to reconcile and consolidate their financial records at the branch level while adhering to standardized accounting practices. The accuracy and integrity of financial records within each branch resulted in transparency, accountability, and better relations between CMBA branch staff and the community partners.

Fortified Convergence. Indeed, CMBA and the CCT Multipurpose Cooperative (CMPC) are united in raising up strong families in the communities. In 2023, the two ministries conducted a Joint Planning and Budgeting Workshop in September to align their strategic thrust and resources. Microfinance frontliners or faith community missionaries (FCMs) and the CMBA officers were also trained on their new job functions, in line with the integration of the core systems—Musoni and RuralNet.

The strengthened collaboration will have an impact on the lives and communities served. CMBA's microinsurance builds resiliency in the event of death or disability, while CMPC's loan products empower individuals to have economically viable social enterprises.

These interventions allow families to break free from the cycle of poverty, and enjoy God's design for peace, stability, security, and favor—as envisioned by both CMBA and CMPC.

Nanay Claren Roque and her fellow community partners at Fellowship 48 understand the combined value of joining both CMPC and CMBA. From someone who had zero savings and no insurance, Nanay Claren has now established a safety net for her family, ensuring their protection and financial security in the face of unforeseen circumstances.





"Insurance helps when disasters or something unexpected come up. As for the savings, it feels great knowing that I have funds saved for future use, especially for covering my loan repayments," Nanay Claren shares.

OVERCOMING CHALLENGES

Manual Systems. Manual recording and data accuracy and integrity across CCT branches nationwide had always challenged CMBA. Despite the daunting amount of work at hand, the steadfast determination of the CMBA staff, and God's sustenance and strength, enabled the ministry to migrate from manual records to a computerized system with complete, accurate, and reconciled data. Furthermore, CMBA has been consistent in its efforts to adhere to regulatory requirements resulting in reliable microinsurance services for its members. Ultimately, the successful resolution of these challenges had not only proven CMBA's ability to stand firm amid complex issues but it also served as a testament to the ministry's wholehearted commitment to pursue excellence for God's glory. Without a doubt, CCT's microinsurance ministry is now poised for greater success in the years ahead.

WAY FORWARD

With its own steadfastness tested and refined, CMBA—through the guidance of the Holy Spirit—vows to foster more resilient families and Christ-centered faith communities through affordable microinsurance services for the poor. Currently, a new product is being developed to serve the needs of individuals aged 65 and above, as well as their families.

CMBA prays for more and more families, especially the microentrepreneurs, to learn the value of being prepared for emergencies and increase support for BLIP-Sigurado.

Moreover, CMBA will further enhance its collaboration with CMPC—aligning ministry goals and objectives to better facilitate wholistic services in the community. Another priority is board governance. All these efforts are geared toward securing more lives, uplifting the poor, and stimulating growth and solidarity among CCT sectors.

With these in place, CMBA looks forward to more years of being a beacon of light to the lost and a wellspring of hope to the grieving, as it draws inspiration from the Word of God.





From Grief to Gratitude

Nanay Jaquelyn and Tatay Angel Balagon lived a simple but harmonious married life in the small town of Matina Aplaya, Davao City. Both faithful believers, the extraordinary old couple exemplified a life filled with joy and love for each other. Nanay Jaquelyn had been an active fellowship group member who was always eager to delve into the Word of God. But her world took a drastic turn when Tatay Angel fell ill and began to experience declining health.

Suddenly, Tatay Angel could not get up and frequently vomited. Nanay Jaquelyn found out about his worsening condition when she took him to the doctor one day. He was eventually admitted to the hospital but unfortunately, it was already too late. Tatay Angel went home to the Lord at the age of 60.

A widow without a child, Nanay Jaquelyn was confronted with overwhelming medical bills and funeral costs that compounded the intense grief she was already enduring. For a moment, she felt hopeless as the weight of her circumstances seemed impassable. But she knew, He who is close to the brokenhearted never once took His eyes away from her. Through the ministry of CMBA, rays of hope pierced through the gloom that once enveloped the 62-year-old widow.

"The insurance benefits of CMBA were a huge help. It covered Angel's hospital bills, funeral costs, and burial expenses. What remained I used as additional capital for my small sari-sari store," Nanay Jaquelyn shares.

A CMPC community partner for 20 years, Nanay Jaquelyn immediately availed CMBA's BLIP-Sigurado for herself and her husband. As a result, Tatay Angel was covered by the expanded insurance benefits which secured his wife from financial burden and even supported her livelihood.

Furthermore, CMBA and other CCT ministries in Davao organized a heartfelt memorial service in honor of Tatay Angel. The dedicated staff wholeheartedly joined the bereaved family, offering fervent prayers and unwavering support during their moments of grief. Currently, CMPC continues to journey with Nanay Jaquelyn as she stands firm in God's shalom—holding on to the blessed hope that Tatay Angel is now watching over her from heaven.

"I praise God with all my heart and thank CCT MBA for the huge help. I highly encourage community partners like me to become members as well," Nanay Jaquelyn says.
